# Family Planning and Support



Family planning and support are two big parts of your amazing Workday benefits! Maven Wallet and your medical plan work together to provide you a combined lifetime maximum benefit of \$25,000.

### Fertility treatments: Medical plan or Maven Wallet

If this sounds like you	Then this is how fertility treatments can be covered:
I'm enrolled in Cigna and/or SimplePay Health, and this is my first time using the benefit.	<ul> <li>You have the option to use the medical plan and/or Maven Wallet benefits.</li> <li>You have a lifetime maximum of up to \$20,000, nontaxable, through your medical plan. Then, you can use Maven Wallet for any remaining balance up to a \$25,000 combined lifetime reimbursement. Maven Wallet covers some services that your medical plan doesn't, but reimbursements through Maven Wallet may be taxed. Using your medical plan coverage first may be more cost-effective.</li> </ul>
	<ul> <li>If you go through Maven Wallet, you'll need to provide a copy of an Explanation of Benefits from Cigna or SimplePay Health, showing any prior claims for fertility benefits.</li> </ul>

For example, if you used the entire \$20,000 fertility</li> </ul>
	benefit through a Workday Cigna medical plan prior to January 1, 2022, the full \$25,000 Maven Wallet benefit is still available to you.
	• The amount Cigna paid for fertility benefits on or after January 1, 2022, counts toward and reduces the total Maven Wallet benefit available to you. For example, if Cigna paid \$10,000 for fertility care in February 2022, you may only access \$15,000 in Maven Wallet reimbursements thereafter.
	• You will need to provide Maven Wallet with a copy of an Explanation of Benefits from Cigna showing any prior claims for fertility benefits.

### Adoption or surrogacy: Maven Wallet

- Reimbursements through Maven Wallet may be taxable to you and may vary by service. Maven is available to help you understand which reimbursements will be taxable.
- Regardless of the amount of adoption and surrogacy benefits you used before, the current lifetime maximum is \$25,000 as of January 1, 2022.

	If this is exhausted, you can use Maven Wallet for an additional \$5,000.	<b>Note:</b> Workmates filing fertility benefit claims through a medical plan on or after January 1, 2022, have a combined lifetime maximum fertility benefit of \$25,000.	
Is the benefit taxable to me?	Benefits paid by Cigna or SimplePay Health are not taxed.	Yes, you may pay taxes on the amount of certain Maven Wallet benefits you use. For more information, review the <b>Maven Wallet plan</b> <b>overview</b> , and/or contact Maven for details.	
How do I file a claim?	No action is required for services performed at network facilities. You must submit a claim form for services performed at out-of-network facilities.	Upload receipts through the Maven Wallet app, and get reimbursed in your paycheck.
